# Section 2: The Haemophilia Centre at Edinburgh Hospital

5. I worked as a newly qualified Staff Nurse in Ward 23 from October 1985 until January 1987. This was a general medical/haematology ward. It had a small treatment room attached where haemophiliac patients could receive treatment as out patients. If I recall correctly, our involvement as ward staff was more in the evenings and at weekends when patients needed to receive Factor VIII.

The Haematology Consultant was Dr Christopher Ludlum, Ward Sister was Margaret MacSween and I think a senior staff nurse in the Haemophilia treatment room was Billie Reynolds.

I cannot recall any other staff names.

6. As this was 35 years ago, I only have a vague recollection. I think that patients were seen and examined by the ward doctor on call who prescribed treatment and this was made up/prepared by nursing staff.

7. I have read through all the questions in these sections and now, 35 years later, feel unable to comment or answer these areas.

My memory, after all this time, is such that I would have no faith that any answers I might give would be factually accurate.
